### NetLibrary Offers New Selected Subject Collections for Libraries

NetLibrary now offers a quick and simplified way for libraries to meet the needs of their users with 'subject sets.'

Subject sets are groups of NetLibrary eBook titles covering specific subjects for public, academic, school and community college libraries. They were developed by NetLibrary collection development librarians and are ideally suited to support heavily-used subject areas and popular degree programs.

NetLibrary has created 62 different subject sets that cover 18 general topic areas, all designed to serve a variety of library and patrons' interests. For example, libraries that need Business content might be interested in six different Business subject sets, including: Accounting, International Business, Economics, Finance, Management & Leadership, as well as the General Business set for less specialized titles. Other subject set titles range from Career Development to Nursing and from Allied Health to Engineering & Technology.

The subject sets contain titles from top publishers, and since titles are never duplicated from set to set, libraries are able to own more than one subject set without overlapping their collections. The sets designed for **Public Libraries** include materials for small business, travel and leisure, personal/career development and "Books with Feet." The **School Libraries (K-12)** sets have resources for children, teachers and school libraries—including materials in Spanish. The **Academic Libraries** sets focus on business (MBA) topics, History, Engineering and Technology; and the sets for **Community College Libraries** feature vocational materials such as nursing, criminal justice, IT and more.

## GENERAL

### OCLC Union Listing Has Become Local Holdings Maintenance

On Feb. 19, OCLC migrated the OCLC Union List service to the Connexion browser. The new functionality is called Local Holdings Maintenance (LHM) in recognition of its scope, which includes materials and purposes beyond those of the old Union List service. As part of the migration, OCLC converted the format of the old Local Data Records (LDRs) to the MARC 21 Format for Holdings Data (MFHD). The conversion to MFHD will allow OCLC to offer participating libraries enhanced services in Resource Sharing, Collection Development, and discovery services that will take advantage of the holdings that staff have entered in WorldCat.

New features include the ability to use Constant Data to create new Local Holdings Records (LHRs), and libraries can now use the Derive command to assist in creating new LHRs – either deriving a second record from an existing LHR for your institution or by editing an existing LHR of another institution.

The MINITEX/MULS staff is planning additional training opportunities to help library staff who maintain their library's MULS holdings make the transition to LHM. Two new webinars are planned in March and early April to cover the use of MFHD in LHM and searching for serials with an emphasis on finding appropriate bibliographic records for LHM functions. A full-day, hands-on training session will be scheduled at Minnesota, North Dakota, and South Dakota locations in April and early May. ### **WorldCat Collection Analysis: Quarterly Update for Current Users**

On Feb. 19 OCLC loaded the quarterly update to the data in WorldCat Collection Analysis. This update includes all changes that libraries had made in their holdings through Jan. 1. All Individual Library Analyses, WorldCat Comparisons, Library Comparisons, and Group Analyses will reflect these updates.

Here is the 2006 quarterly schedule for data in Collection Analysis. All additions and deletions to WorldCat need to be completed by the date in the first column in order to be reflected in the analyses released on the date in the second column.

<u>Cutoff for Updates to WorldCat</u>	<u>Analyses are Updated</u>
Jan. 1	Feb. 19
April 1	May 21
July 1	Aug. 20
Oct. 1	Nov. 19

In addition, OCLC has added "2006" to the date ranges. They have also replaced the date ranges "Pre-1900" and "1900-1949." The period before 1900 is now divided into six new date ranges:

- Pre-1500
- 1500-1599
- 1600-1699
- 1700-1799
- 1800-1849
- 1850-1899

The period between 1900 and 1949 is now divided in two: "1900-1924" and "1925-1949." These new date ranges allow users to view their older materials in greater detail.

### **What's All This Fuss About FRBR?**

As librarians, we have long since gotten used to almost constant change. Nevertheless, it can still be hard to face changes looming on the horizon when we do not fully understand their reasons or implications. FRBR (Functional Requirements for Bibliographic Records) might fall into this category for many of us. Perhaps, if we view it as a means to address user expectations and needs, it will be easier to accept.

Even before Charles Ammi Cutter's *Rules for a Dictionary Catalog* (the 4<sup>th</sup> ed. was published in 1904), a main purpose of library catalogs has been to help the end user find resources. This purpose, or function, of the library catalog continues to inform innovative concepts today, most notably FRBR.\* (See note below.)

FRBR came about in response to nagging questions in the face of new information sources--and most especially electronic resources--that current cataloging rules and practices are trying to accommodate. The questions, as paraphrased by Glenn Patton of OCLC, are: what information is of the most value to users of the catalog?; and, how can that most valuable information be used more effectively? As a result of analyzing these questions, a prominent value of FRBR is that it spells out user tasks and helps clarify how catalogs should function.

FRBR is not a standard. It does not contain rules that one would implement. Rather, it is a conceptual model that will help us restructure catalogs to be more responsive to users' needs. It explains the bibliographic universe in a way that emphasizes the relationships among bibliographic entities. This allows for more collocation of records, more gathering together of related entities at a level higher than the individual bibliographic record. This will simplify displays of search results, and as a result, improve the navigation of a bibliographic database.

A search today in most bibliographic databases results in a list of bibliographic records. Each record is equal in value and there is no hierarchy. If the search is performed in a large, shared database, such as WorldCat, and if the search is for a prolific writer or an often published title, the results can be bewildering at best. A "FRBR-ized" database (one constructed with FRBR concepts) would present results in a more hierarchical manner. For example, a search for Jane Austen in a hypothetical FRBR-ized database might first give us a result with two choices: works by Jane

Austen, or works about Jane Austen. A click on the works by Jane Austen would take us to a list of titles, without yet specifying particular editions. Then, a click on a title would lead us to specific editions of that work. In this example, detailed information about individual publications is hidden or kept back until needed by the searcher.

In this same hypothetical FRBR-ized database, a search for *Pride and Prejudice* might first give us a display that lists the various formats of this Jane Austen work. A click on motion pictures would then lead us to a listing of all the motion pictures. And a click on the 2005 version would result in a list of all the various editions and material types (e.g. VHS, DVD) available.

FRBR concepts are already being used to restructure online databases. OCLC, RLG, and some library system vendors are incorporating the concepts of the FRBR model in various ways. For examples, see the list of references below. If you explore these, you will see that there is no one way to incorporate FRBR concepts.

FRBR concepts are also informing the reworking of our cataloging standards. RDA (Resource Description and Access), the successor to AACR2, is currently under development, and it is incorporating the terminology and concepts of the FRBR model. However, it is not yet known exactly how FRBR will be incorporated because RDA *Part II – Relationships* has not yet been developed.

As a result, we do not yet know the full degree to which FRBR will influence our library lives. This will depend both on the cataloging rules and on system design. One thing we can be fairly sure of, however, is that the FRBR model does not need to be applied to every publication that we catalog. In fact, the vast majority of items we catalog do not need the benefit of FRBR's collocation because they represent only a single publication. Our FRBR efforts, then, can be concentrated on those works that will greatly benefit from the application of FRBR concepts, namely those that exist in many editions and a wide variety of media.

If you would like to get a jump start on a deeper understanding of FRBR and what it will mean for both technical services and public services, I urge you to explore some of the references listed below. And keep in mind, we are embracing this change in order to help our users.

\*Note: FRBR (Functional Requirements for Bibliographic Records) was developed by an IFLA Study Group (1992-1995). For details about the model, please see the list of references below. Also, I want to point out that the upcoming Academic and Research Libraries Day will include a session on FRBR. (Academic and Research Libraries Day will be held on April 28, 2006, at the Minnesota Landscape Arboretum. ## RESOURCE SHARING

### Have You Heard About Deflection?

OCLC is working to implement deflection in WorldCat Resource Sharing of Interlibrary Loan requests. The benefit to libraries is to help cut down on the amount of requests that libraries receive for materials that they do not lend. Libraries will be able to set up deflection through their local holdings data and in their OCLC Policies Directory profile. What follows is a summary about these new "deflection" options.

#### Local Holdings Data Deflection

**What it is:** Deflection on individual items

**Background:** On Feb. 19, OCLC installed Request Deflection for WorldCat Resource Sharing. The defaults for the Lending and Reproduction policy bytes in the local holding record (Field 008 bytes 20 & 21) were set to 'u' for undefined. Until your library staff begin to enter or edit your Local Holdings Records to contain data other than undefined in the 008 20 and 21, no deflection will occur.

If you have specific items that you will absolutely not ever lend to anyone (e.g. archival, reference) you can ask the library staff member responsible for local holdings maintenance to set the local holdings record for that item to will not lend.

#### Policies Directory Deflection (Coming in Summer 2006!)

**What it is:** Deflection based on class of items (e.g. material type, MAXCOST, group affiliation)

**Background:** OCLC is currently writing requirements defining how deflection will work for libraries based on their policies in the OCLC Policies Directory. Lenders will be able to set up deflection requirements in their ILL Policies based on categories. For example, if a user does not

wish to lend AV materials, or has a MAXCOST that is higher than the incoming request's library wishes to pay, the request will be automatically advanced to the next lender. This is deflection at the highest level. Another example may be that your library only loans AV items to libraries in the MINITEX region. You could specify that you only loan AV to MINITEX member libraries. If a library outside of the MINITEX region requests an AV item from your library, it would automatically be deflected.

**NOTE:** If a library wishes to make exceptions to rules set in the Policies Directory, they may do so at the item-level based on Local Holdings Data Deflection, as described above. Whatever information is entered in the local holdings record will override any deflection you set up in the OCLC Policies Directory. More details on this new functionality will be forthcoming in the spring!

The WorldCat Dissertations and Theses database is now available to all U.S. subscribers of the OCLC Base Package and OCLC Collection on FirstSearch. This database contains records for over 5 million items cataloged as dissertations, theses, or published materials based on theses or dissertations, in WorldCat, including titles provided by NetLibrary. The database allows users to quickly and efficiently retrieve records for theses and dissertations. **Please Note:** This database cannot be purchased as a stand-alone database on the FirstSearch platform.
